1. Please notify us if you change your name or address while the declaration is still in force.
2. You can cancel the declaration at any time by notifying us - it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
3. If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that we reclaim, you can cancel your declaration (see note 2).
4. If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
5. If you are over 65 and your total income is over the aged income limit you may be able to claim further tax relief in your Self Assessment tax return.
